

Are solar panels made in Nigeria?

Almost all solar panels and related products are imported with very little local added value. Nigeria currently does not have capacity to manufacture solar panelsbut does limited assembly in volumes that cannot meet up to 10% of market demand by only two operators: Lagos based Auxano Solar and Blue Carmel Energy Ltd based in Kaduna.

Are solar panels taxable in Nigeria?

Previously, solar panels in Nigeria were categorized under Heading 8541, resulting in their exemption from import duties. However, the recent reclassification of solar panels under Heading 8501 has subjected imported solar panels to import charges, including up to 10% in duties and Value-Added Taxes (VAT).

What is the import duty on solar panels in Nigeria?

0% import duty on solar panels under HS Code 8541, but when these panels are imported with other systems as is the case with SHS, they will be classified under 8502 and attract a 5% duty. All other solar components (bulbs, fans, TVs) can attract up to 20% import duty. All licensees shall give first consideration for goods made in Nigeria.

How do solar companies sell solar products in Nigeria?

Solar energy companies operating in the Nigerian market can sell solar products through partners who have marketing and sales agents or through employed marketing staff. Most international manufacturers work in this model, appointing a Nigerian solar (installation) company as their local representative.
